Special Assessment Charges for 2019-20 Tax Roll: Certification, Resolution & Direct Charge Transmittal On motion by Commissioner Moeller and seconded by Commissioner Bunfill, the Board voted 3-0 to adopt Resolution 2019-20 requesting the collection of charges on the 2019-20 tax roll, and to authorize that the charges be directly placed on the tax roll.

- D. District Governance Subcommittee Update The Board had continued discussion on follow up items from the April 2019 meeting.
